## Notes on Contributors

### *Luisa Elena Alcalá*

is Professor of Art History in the Universidad Autónoma of Madrid. Her work focuses on viceregal art of New Spain, especially on the role of religious art and the Society of Jesus. From 2022 to 2025 she directed the research project “Agents: Jesuit Procurators and Alternative Channels for Artistic Circulation in the Hispanic World” funded by the Spanish government.

### *José Araneda Riquelme*

is Postdoctoral Researcher in the project MISGLOB at Università Roma Tre, Italy. His current research examines the role of procurators, communication, and material culture between Lima, Madrid, and Rome in the seventeenth century. He earned his PhD (cum laude, 2023) from the Scuola Normale Superiore in Pisa with a dissertation on the social life of letters from colonial Chile (1598–1670). He is also a researcher in the REDIF project (Universitat de Barcelona).

### *Alexandre Coello de la Rosa*

is Professor of Latin American History and the Philippines at the Universitat Pompeu Fabra, Spain. His main lines of research deal with historical anthropology, chronicles of the Indies, and early modern Spanish colonialism, specially focused on ecclesiastical history of the Marianas and the Philippines. From 2020 to 2024, he was a researcher at Catalan Institution for Research and Advanced Studies (ICREA).

### *Fabian Fechner*

is Post-Doctoral Research Fellow in global history at FernUniversität in Hagen. His research interests include Latin American colonial history, studies in cultural contact, “Empire at home” in German regions, and financing early modern and modern Christian Missions. His doctoral thesis explored early modern globalizing politics and the Paraguayan Jesuit missions. His current research deals with a systematic approach to African cartography (1700–1900).

### *Elisa Frei*

is Assistant Professor of Church History at the Goethe-Universität Frankfurt. She also works as Project Assistant for the Digital Indipetae Database at Boston College and as Assistant Editor of the journal *Archivum Historicum Societatis Iesu*. Her research focuses on the Society of Jesus in the early modern period, its missions in East Asia, and the *Litterae Indipetae*, subjects on which she has published extensively.

*Carlos Gálvez Peña*

is Professor of History in the Humanities Department at the Pontifical Catholic University del Perú (PUCP, Lima), where he earned his BA in History in 1991. In 2006 he earned an M.A. and in 2011, a doctorate in Latin American History at Columbia University in the City of New York. He has taught at several schools in the New York area between 2006 and 2011 (Fordham University, Lehman College and The Fashion Institute of Technology, SUNY). His research work focuses on the production of historiographical discourse in seventeenth-century Latin America and its relationship with the rise of creole national identity and the reform of colonial rule, as well as the appropriation of seventeenth-century political thought by intellectual colonial circles interested in Catholic statecraft. In recent studies, Galvez Peña has also delved into the social networks behind the production of such historical discourse and the formation of cadres of religious and secular bureaucratic elites.

*Rafael Gaune Corradi*

is Associate Professor at the Institute of History, Pontifical Catholic University of Chile, and at the Department of Historical and Geographic Sciences and the Ancient World, University of Padua, Italy. He holds a Ph.D. in History from the Scuola Normale Superiore di Pisa. His current research project is titled *The Thresholds of Global Catholicism: A Prosopography of Subterranean Jesuits—Experiences, Functions, and Choral Biographies (Latin America–Rome, 1626–1767)*.

*Corinna Gramatke*

holds a PhD in Conservation and Art Technology. Her research examines materiality and written sources on artistic techniques in 17th and 18th-century Europe and Latin America. Key projects include studies on art production in the Jesuit reductions of Paraguay (Technische Universität München), Jesuit procurators' procurement travels in Europe (Universidad Autónoma, Madrid), and currently the annotated transcription of José Sánchez Labrador's unpublished 18th-century manuscript on Paraguay (Universität Augsburg).

*Aliocha Maldavsky*

is Professor of Early Modern and Ibero-American History (University of Paris-Nanterre). She has directed the Instituto francés de estudios andinos (2020–2023) and currently heads the ESNA-Mondes américains in Nanterre. A historian of Jesuit missions in the Iberian world, she has also worked on the reasons and procedures for the return of ill-gotten gains to the natives by conquistadors in the Andes (16th century). Her current research focuses the imposition of European animals on the Andes, shedding new light on the environmental and economic history of the colonial Andes.

*Andreu Martínez d'Alòs-Moner*

has been Associate Professor at Gondar University and a member of the research project StateHorn, based at Incipit-CSIC in Santiago de Compostela. He previously worked on the *Encyclopaedia Aethiopica* project at the Hiob Ludolf Centre for Eritrean and Ethiopian Studies at Hamburg University. He has published extensively on Jesuit activities in India and Ethiopia, as well as on the history of the Horn of Africa during the early modern and modern periods. He is currently involved in a five-volume project to edit the last remnants of unpublished missionary letters from Ethiopia, preserved at the Arquivo Distrital de Braga in Portugal.

*João Vicente Melo*

is Ramón y Cajal fellow at Universidad Pablo de Olavide, Seville, Spain. His main lines of research explore early modern Iberian overseas expansion, cross-cultural diplomacy, and early modern religious missions in Africa and South Asia.

*Beatriz Nowicki*

holds Master's degree in Social History from the University of São Paulo, with a dissertation entitled "From Indoors to Outdoors: Jesuit Administration in Portuguese America (Bahia and Rio de Janeiro–17th Century)." Her main research focuses on the history of the Society of Jesus in the Americas, examining how the Jesuits managed their lands and productive units, and how they governed enslaved populations. She also develops studies on the moral theology of slavery and the broader forms of domination within colonial society.

*Cristina Osswald*

has a PhD from the European University Institute, Florence, Italy, on Jesuit art in Goa. She is presently a lecturer of History at the Macau Polytechnic University, and an integrated researcher of CITCEM-Universidade do Porto. *Vanina Scocchera*

holds a PhD in Art History and Theory (Universidad de Buenos Aires). Her recent research focuses on the funding of the Asian missions from a local and global perspective. She is the author of *Devenir japonais. *Guillermo Wilde*

is Full Professor and Researcher at the National Scientific and Technical Research Council of Argentina (CONICET). He is specialist on religious conversion in global perspective, ethnohistory and Colonial Latin American History. He has extensively published on the Jesuit Missions, Guarani history and music and the arts in colonial past. He was awarded the LASA Iberoamerican Book for

*Religión y poder en las misiones de guaraníes*. He is currently director of the Research Institute in Social Sciences and Humanities (ICSOH-CONICET-Salta National University).

*Alexander Winkler*

is currently a research associate at the Research and Competence Centre for Digitization Berlin (digiS). He has a background in Neo-Latin and Italian philology, with a particular focus on the Neo-Latin literature of the late 16th and 17th centuries in Italy and Germany.

*Carlos Zeron*

is Full Professor at the Universidade de São Paulo (Brazil) and a member of the Accademia Ambrosiana (Italy). He was a visiting Professor at the Ecole des Hautes Etudes en Sciences Sociales (France), at the Universidad Internacional de Andalucía (Spain), at the Pontificia Universidad Católica de Chile, and guest Researcher at the Musée du Quai Branly (France). His main lines of research deal with amerindian and african slavery, colonial legislation, modern juridical thought, and political theology. He published *Ligne de foi.
